# **Dual Checks for Super Decathlon VH-UPG**

### General

Just some notes on the typical content of dual checks required for solo flying of VH-UPG. The initial check would apply to a pilot who had previously undertaken training in tailwheel and aerobatics on a post-1994 Super Decathlon. Transition from other model Decathlons would require the SE Endorsement Questionnaire plus additional flight exercises.

### Initial Check

- Capture details including
  - ARN, pilot licence, medical and ASIC
  - Email address to DJP for email updates
  - Requirement to pay on completion of flight
- Confirm endorsements on licence:
  - Manual propeller pitch control
  - Tail-wheel landing gear
  - Spin
  - Aerobatics
- Access to <a href="http://ozaeros.net.au/">http://ozaeros.net.au/</a> website including holding of aircraft documents (pages are protected by a password):
  - Checklist
  - Pilkington Operating Notes
  - Approved Airplane Flight Manual
  - Operating Manual
- Knowledge of operation of Super Decathlon VH-UPG
  - Review previous SE Endorsement Questionnaire if not available or not done then a new one is to be provided for review.
  - Refer specifically the Pilkington Operating Notes including:
    - Oil to use
    - Leaning on ground and in flight
    - Technique for short field landings and distance required
    - Power setting for climb, aerobatics, cruise and descent
    - Counting aerobatic time for component fatigue life
    - Limitations associated with Manoeuvre Speed:
      - what is it?
      - max control application below VA?
      - max control application above VA?

# **Dual Checks for Super Decathlon VH-UPG**

- 8KCAB SL 445 Aerobatic Maneuvering and Aileron Application
- Operation of the MT propeller throttle response, gravel and rain
- Prohibited manoeuvres plus snap/flick rolls
- Ground handling including use of tow bar
- Securing the harnesses in flight
- Securing the aircraft on the ground pitot tube cover, vents and controls. Tiedown if required esp tail (use the leaf spring only).
- Aviation security regulations.
- Hangar protocol
- Approval is required for flights away from Moorabbin. A fly-away kit, including mixture lock, tie-downs, portable GPS and fuel carnet cards, is available.
- Key knowledge of aerobatic operations including:
  - Spin recovery technique refer the manuals
  - Weight and fuel limits refer the AFM and SL 448
  - Techniques for the aerobatic manoeuvres to be flown refer the manuals
- The quizzes (password is quiz) on the <a href="http://ozaeros.net.au/?page\_id=675">http://ozaeros.net.au/?page\_id=675</a> website cover much of the above and will save time in doing the check

Refer to the book Aerobatics Down Under - the B&W edition is provided to regular pilots. Finally, complete a flight check as appropriate for experience, currency and scope of operation.

# **Currency Check**

- 90 day checks on Super Decathlon VH-UPG by an instructor authorised on the insurance policy (note: after an initial tailwheel endorsement the first dual check should be at 45 days unless satisfactory solo circuits are completed)
- Typically a circuit flight check and knowledge check of items from the initial check above

# Regulatory Requirements

Refer 61.375, 61.380 and 61.385. Note especially:

- "(1) The holder of a pilot licence is authorised to exercise the privileges of the licence in an aircraft only if the holder is competent in operating the aircraft to the standards mentioned in the Part 61 Manual of Standards for the class or type to which the aircraft belongs, including in all of the following areas:
- (a) operating the aircraft's navigation and operating systems;
- (b) conducting all normal, abnormal and emergency flight procedures for the aircraft;
- (c) applying operating limitations;
- (d) weight and balance requirements;
- (e) applying aircraft performance data, including take-off and landing performance data, for the aircraft."
